Caretaker agrees to indemnify and save and hold harmless PPL from any and all actions, causes of action, claims, demands, damages, costs (including reasonable attorney fees), loss of services, expenses, compensation, and all consequential damages caused by Caretaker's breach of this agreement. Caretaker assumes full responsibility for and risk of bodily injury, death or property damage related in any way to the pony (ies) retired under this Agreement
